Well Fargo Quantitative Internship Program

Wells Fargo's Quantitative Internship program begins in June 2019 and is a 10-week summer internship designed to provide qualified candidates quantitative modeling work experience within our Capital Markets business as well as the Credit and Operational Risk businesses.

Interns in the Capital Markets track will develop and validate mathematical models for pricing, hedging and risking complex financial instruments. Wells Fargo trading portfolios include products in all traded asset classes such as credit, commodity, Equity, FX, Rate, Mortgages and Asset-Backed Finance.

In our Credit & Operational Risk track, interns will develop statistical models for loss forecasting, credit risk scorecard, risk segmentation and stress testing for a variety of lending products and operational risk processes.

Responsibilities may include:

- Performing core mathematical, statistical, and machine/deep learning model development and validation
- Leading and participating in model risk projects supporting varying purposes, methodologies and lines of business
- Staying up to speed on industry challenges and new and innovative modeling techniques to ensure Wells Fargo maintains "best in class" practice
